LISTENING SESSIONS



On September 2, 2020, the SMART Board of Directors launched a community-wide Listening Tour across Sonoma and Marin counties, hosted on Zoom, to bring community members together to exchange ideas on how to best position SMART for the future.




SMART office staff participated in #RedOutForRailSafety for the fourth year in a row, showing our support for rail safety awareness.



Multi-Use Pathway Project

Sonoma County Pathway Gap Closure Project:

- South Point Boulevard in Petaluma to Main Street in Penngrove (4.4 miles)
- Golf Course Drive in Rohnert Park to Bellevue Avenue in Santa Rosa (4.5 miles)

The Designer, GHD Inc., and their subcontractors gathered preliminary engineering data including environmental, geotechnical, and survey. SMART and the Design team are carefully examining the future Non-Motorized Pathway best location option.


OPERATIONS

MAINTENANCE OF WAY:

- Signal staff repaired knock down due to large truck collision at the Francisco crossing in San Rafael.
- Track and Signal staff replaced a track insulated joint south of East Cotati crossing adjacent to the platform.
- Signal staff along with outside contractor replaced Air Conditioner unit at Rohnert Park station signal house.
- Track staff completed vegetation removal management south of Civic Center, Puerto Suello tunnel area, and south of Roblar crossing in Novato.
- Track staff provided daily flaggers for Highway 101 freeway overpass in Petaluma and flaggers for various other project twice a week on average.
- Facilities staff completed 11 fence repairs at various locations along SMART's right of way and started a small fence project adjacent to the Larkspur office trailer.
- Facilities staff completed a resolver motor replacement that interfaces with the computer at the Haystack Bridge.
- Signal staff is meeting with Alstom signaling for field support and training.

TRANSPORTATION:

- Federal Railroad Administration (FRA) Region 7 Operating Practices Inspector reviewed and discussed SMART's Operations and had questions regarding freight service.
- Safety Meeting was held at the ROC on September 23, 2020

SMART Transportation Department Training:

Currently reviewing online training programs for year 2021.

VEHICLE MAINTENANCE:

- Performed mid-year maintenance on 2 Diesel Multiple Unit.
- Performed 500-hour oil change on 3 Diesel Multiple Units.
- Automatic Train Control maintenance performed on 13 Diesel Multiple Units. This maintenance keeps us compliant with Federal Regulatory Association regulations in regards to positive train control.
- Performed data downloads on the fleet. The Diesel Multiple Units have many subsystems that are integrated. Downloading the systems data provides SMART an opportunity to investigate different occurrences that may not show during our normal inspections.
- Performed emergency exit window pull test on 4 of the Diesel Multiple Units. The test is to
 establish confidence per the Code of Federal Regulations that the emergency exit windows
 will react as designed during an emergency.

FREIGHT SERVICE

At the September 2, 2020 Board Meeting, I provided an update on the status of Freight Service and related activities. The Board on May 20th, approved a number of policies establishing SMART to become a Freight Service provider. The following activities have taken place and are ongoing:

- The State of California has been funded the \$4M for the purchase. The funds have been encumbered and deposited into an escrow account;
- The State of California has funded the \$2 million for SMART for freight maintenance. The funds have been encumbered and deposited into an escrow account;

SMART has not spent any agency funds to purchase NWPCo. All the funds are from the State of California and deposited into an escrow account.

The following two Agreements are pending execution: 1) The Asset Transfer Purchase Agreement between SMART and NWPCO. This agreement is for SMART to purchase the assets once the funds are received; and 2) The Baseline Agreement between the State of California and SMART has been finalized and is pending execution. Both of these Agreements will be executed upon release of the report from the State Task Force to the State Legislators as required by SB 1029. The provisions of SB 1029 states that upon the completion of due diligence by mid-September.

REAL ESTATE

Private Crossings

Staff is continuing to work on researching SMART's ownership, property rights of ingress and egress easements and current and necessary agreements along the Brazos Branch. One property owner on the Brazos Branch, that is immediately adjacent to the tracks, requested a private crossing agreement which was sent to the owner. Staff is continuing to talk with the property owners' representative.

Property Acquisitions (in process)

Windsor Extension Project: Staff is continuing to research property rights that were granted to third parties on or along the new extension. Staff is working to remove any encroachments on SMART property. Staff is continuing to work with the various utilities along the extension on a variety of property issues

North Coast Rail Authority (NCRA): Staff is continuing research on the real property assets that will be transferred if the agreement is approved by all the authorizing agencies.

Track work: Research continues on property rights for both SMART and property owners regarding the location of track.

Pathway: Coordinating with the adjacent property owners and local municipalities regarding securing any necessary land rights to accommodate the construction of the pathways and interim access and laydown area needs.

GRANTS, LEGISLATION, PLANNING AND REGIONAL ACTIVITIES

REGIONAL AND LOCAL PLANNING ACTIVITIES

Local Planning Department Notification and Coordination Tracking - SMART Planning Staff also tracks and reviews all notices sent by local jurisdictions for projects occurring adjacent to or nearby the railroad tracks. In 2019 staff received and reviewed 171 different notices, with 131 notices by September 2019. To date in 2020, SMART has received and reviewed **<u>89</u>** different notices.

SYSTEM ACCESS PLANNING ACTIVITIES

Bike Share: The Sonoma County Transportation Authority (SCTA) and Transportation Authority of Marin (TAM) are implementing a Metropolitan Transportation Commission (MTC)-funded bike share system in close proximity to the SMART stations as a First/Last-Mile access solution. SCTA & TAM have selected Gotcha Mobility as the operator of the Bike Share Pilot Program. The pilot program will roll-out 300 GPS-enabled electric bicycles for three years centered around SMART stations. Due to COVID-19, the program implementation timeline has been impacted by community outreach and manufacturing limitations. Gotcha Mobility, the selected implementation vendor, is currently planning to commence community outreach to inform bike share locations in November and they estimate program rollout by Spring 2021.

Clipper START Program: In 2015 MTC launched a study to determine if a transit fare program based on household income would be feasible and effective. SMART has been participating in the MTChosted Clipper START Program, with monthly meetings and a recent launch of a Clipper-based means-based fare 18-month pilot program on selected regional transit operators, which include BART, SFMTA, Caltrain & Golden Gate Bus & Ferry. At the February 5, 2020 meeting, your Board unanimously approved Resolution Number 2020-05 which authorized SMART's formal request to participate in the regional Clipper START Low Income Fare Program. MTC recently announced they are now able to accept new operators into the pilot program using \$5.1 million of CARES Act regional funds to help offset up to 10% of lost fares. SMART is working with MTC to join the program with Clipper estimating a November 2020 launch

Transit Coordination Meetings:

- September 2, 2020 Staff participated in the Metropolitan Transportation Commission (MTC) monthly Transit Finance Working Group meeting. Discussions included legislative updates, funding notices, Transportation Improvement Program update, Cap and Trade Update, TNC Access for All, Regional Measure 3 Update, CARB/ICT Update, Clipper START Update, COVID-19 Response, and Regional Transit Capital Priorities FY21 FY25 Call for Projects.
- September 9, 2020 Staff participated in Sonoma County Transportation Authority's monthly Transit Technical Advisory Committee meeting. Discussions included transit operator updates, regional funding updates, and Bay Area Transit Safety & Health Plan.
- Aug 4, 5, 12, 18, 25; Sep 1, 11, 15, 18, 22, 29 Bay Area Transit Operator coordination meetings. SMART staff met with the Bay Area's smaller transit operators, defined as any except the seven largest, weekly to coordinate comments and activities associated with COVID-19 response and presentation preparation requested by the MTC Blue Ribbon Task Force.
