To encourage steady and increasing ridership going forward, I believe it is imperative that SMART Board and staff assist in any way possible to facilitate new multi-residential TOD developments near all SMART stations.

In particular, the unsightly and vacant 4.5 acre parcel owned by SMART that is adjacent to the Downtown Petaluma SMART station (see attached aerial) should be sold (or land lease) to the most qualified apartment/condominium developer ASAP as an obvious and immediate strategy to increase ridership.
